



Despite what you may have heard, the need for all professional, vocational drivers (Category C and Category D licence holders) to hold a valid driver qualification card (DQC) is not going away because of Brexit and undertaking at least five days (35 hours) of Driver CPC approved periodic training within every five-year period is not going away either.

Approved Driver CPC Periodic Training Courses

Between 8th December 2018 and 31st August 2019, we are providing ten separate Driver CPC approved periodic training course dates, to be presented on one Saturday each month, with the choice of five different course subjects.

So, every professional, vocational driver has the opportunity to undertake five different courses before the next Driver CPC cut-off date of 9th September 2019, to ensure that they have a valid driver qualification card (DQC).

PLEASE NOTE: To comply with the requirements of providing approved Driver CPC periodic training courses we are legally bound to ensure that all the above training courses contain at least 7 hours of training. This means that if the course begins at 08.00 and within the day there are 2 x 15-minute comfort break periods (i.e. one in the morning and another one in the afternoon), as well as a 30-minute break for lunch, the training day will not be completed until 16.00, at the earliest. Should anyone not be in attendance for 7 hours of training we will be unable to register them as having successfully undertaken the approved training course. Therefore, if you book to attend a course and you expect to receive a DVSA registration against your driving licence as having undertaken the course, you must be prepared to stay for the whole day. This is a mandatory requirement of the Driver CPC approval body - the Joint Approvals Unit for Periodic Training (JAUPT).

Cost of attendance on any of the above 'open to all' course dates is a TOTAL of £75.00 per delegate

The total fee of £75.00 includes the £8.75 DVSA registration cost, the £11.04 VAT element of the overall cost, refreshments and a buffet lunch.
So, any course shown as costing £55.00 + VAT + DVSA Registration + having to pay for lunch separately will be more expensive than us!

PLEASE NOTE: TERMS OF BOOKING The attendance fee must be paid at least seven days before the day of the course - credit and debit cards are accepted (NOT AMEX) and cheques, made payable to 'Truck (UK) Limited'
- a VAT invoice will be provided - cancellation of attendance within 7 days of the course date will result in loss of fee
